Fund Holding

 All this - with more to come - has cost the Council annually less than the budget for the proposed improvements to the Rock-a-Nore public Toilets -£53,400?

The Trust's Aims for 93/4 are to continue to work for the Town and create further partnerships to increase the funding that it can attract, to work in the following areas:

- ENVIRONMENTAL ENHANCEMENT
- BUILT ENVIRONMENT
- PROMOTION OF GOOD PRACTICE IN CONSER-VATION
- FUNDING ADVICE
- RESOURCE ASSISTANCE TO LOCAL GROUPS AND ORGANISATIONS

The Trust asked for funding of £52,000 for 93/4 - 92/3 level of grant support with inflation added.

The total lack of funding support from Hastings Borough Council would effectively end the Trust's ability to function and thereby lose the Town a valuable resource which will not be replaced. The Trust's status as a charity enables it to attract funds not available to the Borough Council or private businesses, and it can use its position to create partnerships between the public, private and voluntary sectors to carry out projects and schemes which would otherwise languish through lack of funds. The Trust also has the ability to work outside the strictures that central government lays upon local government, and can thus be a channel for services and funding which would otherwise be difficult, or impossible, for the Council to pursue.

EDITORIAL

Well, it's been 12 months since the first issue of the Trust's Quarterly Newsletter. Have we achieved all that we have set out to achieve? Or did we fail miserably?

In the first issue, the Burton Memorial Garden, on West Hill Road, St. Leonards featured prominently. Our aim was to complete this project, bringing to an end 30 years of stagnation. I am happy to report that this was completed in the Summer. We will now build on that success by securing the long-term maintenance and further enhancement of this now pleasant community garden.

Also mentioned in issue 1, the 100 Steps, on the West Hill. Work has now started and should be completed by early Spring 1993.

Community Desk Top Publishing was made available to outside community groups. Many individuals and organisations continue to use these facilities, via the Community Resource Centre. A trend we will encourage and promote.

Another project that has progressed positively is the Cooper Barnes Site in George Street - a project in which the Trust has played a primary role in enabling the community to forward their plans to the Council for an open site.

I could give a "blow-by-blow" account of all the projects initiated, enabled, managed, completed, etc, but I think that this publication might not be big enough. So, simply read the following list of some of the projects in which your Trust has played a role.

FUNDING

Trust members will be aware of the fight over our support funding from HBC for 93/4. The question has been highlighted because of the lack of consultation and negotiation with the Trust before the cut was made. Following the 100% cut which went through the Planning Committee in November, a petition was quickly organised to allow the Trust to present its case to the Policy Committee on December 3rd. We were allowed the statutory five minutes in which to lay out the argument for continued support from the Council, plus the right to negotiate a level of funding which would allow the Trust to function. There was a question and answer session followed by the vote which, happily, went in our favour. The Trust is now in negotiation with the Borough Council over the exact level of support it is to receive in the coming financial year.

It is vitally important that Members are aware that there is a figure below which the Trust cannot fulfill any of its aims and objectives for the town. Over the past year w have actively pursued a policy of trying to match £ for £ the support that HBC gave, by whatever means available to us, and we have succeeded. We shall do the same next year, provided that the level of core funding support is adequate. There will be a meeting of the Policy Committee all day on January 22nd, during which our funding will be discussed. Do please lobby your local councillors on this issue and come along on the 22nd to show your support.
