#### Issue 19

Following negotiations with BTCV the Trust is now subcontracting as a provider of the Environmental Task Force (ETF). We have recruited our first participants and have patted our own ETF to subark on projects.

The scheme has already proved to be a success by instigating full time employment for one keen participant within two weeks of operation. We believe this is due to the variety of training and resources the Trust can offer and the dedication and enthusiasm of all members of staff to accommodate people, harness partnerships and strive towards a better Hastings.

Indeed, the broad and diverse range of activities participants are currently involved in supports this and during the past months all the participants, including staff, have overcome initial anxieties and are now finding their feet.

It's SRB bidding time again. The Government Office of the South East issued guidance on which areas were eligible to bid this time round and Hastings had two areas which met the criteria: Castle and Central St. Leonards wards. There was also a requirement for a high level community consultation in the preparation and implementation of the bid.

Meetings were held in the two wards and a list of needs drawn up with projects which could answer those needs identified.

The areas which emerged were:

Improving the Living Environment by a series of small scale environmental improvements and measures to secure a reduction in domestic burglary in both wards.

Increasing employability and address social exclusion by targeting vulnerable groups within the Wards and providing access to training and support. The targeted groups will include those suffering from numeracy and literacy problems, substance misuse and mental and physical disabilities.

**Create jobs** through advice to local businesses (including energy efficiency), access to training for employees and the promotion of community enterprise amongst residents. Enhance community capacity building by providing support and accommodation which will be a focus for community activity, information exchange, health provision and a centre for outreach work. Within Central St. Leonards this accommodation will be provided within a redevelopment of a derelict site for mixed use including the above accommodation, workspace and housing.

The bid totalled £1.9 million and the Partnership will hear whether it has been successful sometime towards the end of December, early January.

SEEDA (South East England Development Agency) The Government has put forward a clear regional agenda for England which, in broad terms, is intended to give a greater voice to the regions and, eventually, to devolve some of central government's powers to the regions. The establishment of the South East **England Development Agency** is well under way, with the appointment of Allan Willett, a Kent-based international businessman, as Chair. The agency will be formally established until April 1999, when the RDA Bill receives the Royal Assent.

SEEDA will take over the Government Office of the South East's (GOSE) responsibilities for the management of the Single Regeneration Budget and absorb the regeneration work of English Partnerships and the Rural Development Commission. It will also relate closely to the SE Regional Investment Limited and the South East Regional Forum and the Voluntary Regional Chamber when it is established, as well as with the local economic partnerships.

Allan Willetts has outlined his a personal goals in three main points:

The region as a whole continues to prosper and eventually becomes one of the most successful in the world

The more disadvantaged parts of the region are helped to improve their economies and standards of life.

We maintain not only our way of life, but also the green and pleasant land which is in the South East.

Allan Willetts will be making a whistle stop tour of East Sussex in mid-January, when we shall be meeting up with him for talks on development and regeneration. Watch this space.

The Trust is working with HVA on the Voluntary Sector Regional Network to ensure that the voice of the voluntary and community sector in Hastings is represented.

### GRANTS FOR GROUPS

The Hastings Community Fund has issued its first grants to local community groups and voluntary organisations and will be issuing a second tranche during the New Year.

The fund has been set up using conies secured by the Hastings Regeneration partnership under SRB III. There is £376,000 to be spent over the next six years to achieve the following outputs and outcomes:

To harness the energies of an active voluntary and community sector to enable it to contribute fully to the process of regeneration by developing capacity building across all sectors of the community.

To increase the proportion of Juntary and community organisations actively participating in regeneration projects and increase the number of individuals involved in voluntary and community work. the scheme is specifically for local groups and organisations which provide services and activities that benefit the residents of Hastings and St. Leonards.

He was very impressed with the work that is happening in the Ore Valley.

Due to the increasing demand for space we have now expanded to another flat – 46 Chiltern Drive. All the normal services and telephone numbers will remain the same, but this will just give us a little more space. The Baby Clinic on a Monday afternoon will now be available from this flat, along with a Family Drop In on Tuesdays. Workers are available for the children, as well as snacks for all to enjoy.

With the interest and future planning of Healthy Living Centres, Clare and Sue were recently asked to make a presentation at the Hastings Voluntary Action's Conference about the role that Voluntary Organisations play in developing a Healthier Nation.

The Community Newsletter continues to prove to be a popular asset to the local community, and is now entirely written, edited, produced and distributed by local resident volunteers.



Sarah "Bubbles" Taylor has been making great inroads into the projects future funding. We are currently awaiting replies to £23,000 worth of funding applications. Sarah has collated further funding information which should allow us to increase our bids to approx. £80 - £100,000 by the end of February 99. Obviously, we may not secure this amount, but we can but try.

We are hoping for a full social activities calendar for 1999 with events ranging from sponsored walks and bike rides to raft races and our full autograss racing season. It is also hoped that the motorcycle side of the project will be resurrected to the point where we can begin our motorcross schooling days again and have young people competing in local motorcycle trials.

#### Volunteers

So far the centre has been helped by over eighteen volunteers, some very able and experienced.

#### Centre Database Development

Databases were created or improved by the Information Coordinator including: The Reception Database which monitors the use of the Centre; The Trust Address database, The Local Agenda 21 library database; the Centre Library database; the Centre Accounting datbase and the Volunteers database.

#### Other Databases Installed at the Centre

Ecocal was donated by Going for Green. Ecocal calculates how Green your life style is.

Funder Finder helps people to search for funds for community projects.

Locally developed databases have also been installed: the directory of the GEMS database (the local LETS); the Women's Network database which is being entirely reconstructed in an improved form at the Centre, and the Hastings and Rother Federation of Information Providers database.

#### Fund Raising

A business sponsor partnership group was created to assess the Centre's future and projects: Springboard Marketing Lifetime Training Solutions (a national training company) and the Institute of Marketing [Sussex] through 1st Place Ltd.

#### Statistics

From November 1997 to August 1998 there were 1142 visits to the Centre which averages at 120 a month. Since completion of the Centre there have been dramatic increases.

Since July 15th when the Reception Database began monitoring visits. Here are some statistics up to November 30th 1998

Number of visits to Trust and Resource Centre in these four and a half months: 1131. The figures for the four complete months that the database has recorded show: in August there were 158, in September, 271 in October 245 and in November 352.

The number of visits can be broken down into type of visit, what services where used, whether a Resource Centre member of staff was seen or another member of the Trust's staff, and which member of staff. By sector (see pie chart) there were 185 visits by the voluntary sector involving 26 separate voluntary organisations; 100 by the business sector; 119 by the statutory sector. On top of this there were 62 visits by individuals and 24 by artists as well as 31
